Where Have Our 180 Days Gone?!?

From PVFA Bargaining Team

“Why has the district not put instructional days back on the school calendar?” This is the number one question asked by and to the members of the bargaining team. We have many concerns. Yes, enrollment is down about 80 students throughout the district. However, the funding for the district will be based on the higher ADA number from last year – essentially bringing in more dollars for our students.

Next, the federal jobs bill money (**\$2.2 million**) could have been used to add days back to calendar. (In fact, only \$880,000 is needed to bring back the four instructional days for students and teachers.) Additionally, PEF donated \$1.5 million to save teachers jobs and to keep class sizes small.

Lastly, in 2010 teachers agreed to take six (6) pay cut days, (four of which were instructional). This was to save teachers jobs and keep class sizes small. **So, why are class sizes bigger than ever and why do we have 13 fewer teaching positions?? NONE OF THIS ADDS UP!**

The mandatory 3% reserve is at 6%, in the general fund. When we add up all the other “funds” – they are **FAR** in excess of the required amounts. So, again – ***“Why has the district not put instructional days back on the school calendar?”*** **Where are the district’s priorities? And where is all the money going??**
