

CTA Virtual State Council
January 2021





This meeting was again held virtually due to the COVID-19 pandemic. Committee meetings were spread out over the week of January 18-23, culminating with our General Session on Saturday, January 23.



State Council voted to re-elect our executive officers. CTA President Toby Boyd, Vice President David Goldberg, and Secretary Treasurer Leslie Littman will continue their leadership of our association.

State Council also voted to increase representation for our retired members. CTA/NEA retired membership has grown to over 19,000 members but they currently have only 4 State Council delegates. Under the new representation rules, CTA Retired will now have 9 State Council seats.


Committee Reports & Resources

- The Civil Rights in Education Committee has been conducting a 3-part series on Ethnic Studies. You can access recordings of previous sessions as well as register for the final session on January 26: 1/12/21: What is Ethnic Studies as a discipline?, RSVP for 1/26/21
- Credentials & Professional Professional Development Committee reported that the CTC is currently undertaking a 'refresh' of the California Standards for the Teaching Profession (CSTP) and is seeking public input and comment. Since many local districts use the CSTPs as part of their evaluation process, it is important that our members express their concerns and thoughts about the revised standards. - Curriculum & Instruction Committee recommended an interim position of Co-sponsor on AB 101 (Medina) which would provide Ethnic Studies as a graduation requirement. This is the same bill that C&I supported last year (AB 331) and was vetoed by the governor.
- Retirement Committee offered the following statistics on retirements so far this year:
 The numbers below represent people who have already filed for retirement this year when compared to other years.

Year	2016	2017	2018	2019	2020
Total (Jul-Dec)	4,254	4,499	4,815	4,467	5,644

As a result of the significant increase in the number of service retirements fiscal year-to-date, CalSTRS surveyed most of the members who have retired to determine if they had retired earlier than planned and if so, what were the contributing factors. As of January 7, 2021, 517 responses have been collected and 62% indicated they had retired earlier than planned.
