

MEMORANDUM OF UNDERSTANDING BETWEEN
THE CENTINELA VALLEY UNION HIGH SCHOOL DISTRICT (CVUHSD), AND
THE CENTINELA VALLEY SECONDARY TEACHERS' ASSOCIATION (CVSTA)

Period 0 and Period 9 Class Periods

October 19, 2021

Having met and negotiated in good faith, the Centinela Valley Union High School District (CVUHSD) and Centinela Valley Secondary Teachers Association (CVSTA) agree to the following terms and conditions with respect to utilizing Period 0 and Period 9 to provide student instruction.

The parties agree that this agreement shall be effective upon the execution for the 2021-2022 school year.

1. Students may be enrolled in Period 0 or Period 9 for either in-person or Independent Study (IS).
2. Period 0 in-person (APEX or direct instruction) class(es) shall be offered on regularly scheduled school days (Tuesday-Friday) from 7AM-7:54AM.
3. Period 0 IS classes shall have synchronous instruction at least once a week on a regularly scheduled school day (Monday, Tuesday, Wednesday, Thursday, or Friday). Each period's weekly synchronous meeting time shall occur 7:00am to 7:27am, or 7:27am to 7:54am.
4. Period 9 in person (APEX or direct instruction) class(es) shall be offered on regularly scheduled school days (Tuesday-Friday) from 3:05PM-3:59PM.
 - i. On minimum day schedules the period will not meet.
5. Period 9 IS classes shall have synchronous instruction at least once a week on a regularly scheduled school day (Monday, Tuesday, Wednesday, Thursday, or Friday). Each period's weekly synchronous meeting time shall occur 3:05pm to 3:32pm, or 3:32pm to 3:59pm.
 - i. On minimum day schedules, IS weekly after school synchronous instruction will not meet.
6. Period 0 and Period 9 will be offered as extra duty assignments for which teachers will be compensated at 1/6 (one-sixth) of the unit member's daily professional rate ("per Diem" rate) for each period when students are enrolled in the period.

- i. In addition to the per diem rate, unit members teaching in person APEX or direct instruction classes, shall receive an additional \$40 per day the class is scheduled to meet for each Period 0 through Period 9 extra duty assignment.
- ii. In addition to the per diem rate, unit members teaching IS classes shall receive an additional \$140 per week the IS class is in session.

The District and CVSTA agree that the terms of this MOU are not precedent-setting and do not establish or contribute to any past practice. This constitutes the entire understanding of the parties and is not subject to change or modification without the express, written consent of the other party.

The MOU shall be effective upon execution of the Parties and Board approval and shall expire on June 30, 2022.


