## ARTICLE 6 - 3

**6-3** In addition to the above minimum time and required work days, unit members are responsible for adjunct duties beyond their instructional duties, which include but are not limited to, program development, professional growth activities, parent conferences, committee assignments, faculty and District meetings, special help to student(s), back-to-school nights, student supervision, communication with parents **and students regarding student performance** (using district provided technology), and other assignments which are deemed to be necessary for the efficient operation of the school. The District's intent is that such adjunct duties relate to the instructional program.

At the secondary level (grades 6 - 12), a District adopted online gradebook shall be maintained and updated by the unit member at least each month.

Grades shall be submitted electronically through the District adopted system by the unit members at all grade levels at the designated reporting periods. Grading and reporting period dates shall be provided at the beginning of the school year by the site administrator or designee.

### ARTICLE 7 – 1

PVFA proposes a two-year agreement (2016-17, 2017-18) of a 1.0% ongoing increase to the base salary schedule effective January 1, 2017 and an additional 2.75% increase to the base salary schedule effective February 1, 2018.

The District and PVFA agree to no re-openers for salary or benefits for the 2016-17 and 2017-18 contract years. Reopeners will be limited to two articles from each party and specific proposals will not have any fiscal impact.

# Article 7-9 Appendix B

Compensation to unit members for District-approved extra-pay assignments shall be a mutually agreed upon percentage to be cost neutral based on their placement on the current teachers' schedule A (effective July 1, 2017) not including career increments.

The District and PVFA will establish a task force made up equal representatives to address the structure of extra pay assignments and make recommendations to both parties by March 31, 2018.

### 12-1 Transfers

### **Special Education**

Changes in the assignment of traveling unit members and changes in the assignment or transfer of Special Education unit members (Special Education Teachers, Resource Specialists and Speech Therapists) or Reading Resource teachers to coincide with individual school enrollment and/or needs are not considered transfers or reassignments subject to the provisions in this article. The assignment for Special Education unit members is determined by the Student Services Department and is governed by a number of critical factors such as the fluctuating numbers of special education students throughout the school district and at each site, the changing nature of the delivery of special education services, the changing educational needs of individual sites and the credentials of a unit member.
